Module 1 Lesson 1 Exercise 1 – Cyber Resilience Responsibilities

Plan to spend 30 minutes on this exercise.

Exercise scenario

You should refer to the Lune Associates case study for this exercise.

Lune Associates has established a number of programs to pursue its new business strategy. These include an IT transformation program.

The Chief Information Officer understands that the proposed new services are secure and has created a new role – Cyber Resilience Manager – to be accountable for ensuring that Lune Associates manages its security risks so that it can confidently continue to deliver its business strategy and desired outcomes.

Module 1 Lesson 2 Exercise 2 – Introducing Cyber Resilience

Plan to spend 30 minutes on this exercise.

Exercise Scenario

You should refer to the Lune Associates case study for this exercise.

The CIO has asked the newly-appointed Cyber Resilience Manager (CRM) to provide an overview of how they intend to proceed and who will be involved. The CIO is particularly concerned about how quickly the project will deliver visible benefits and has reminded the CRM that money is available for buying-in outside help.

The CRM considers that Lune Associates is not a green field site, it already has some security controls and processes in place, so the introduction of cyber resilience is best treated as an improvement project. The CRM is an ITIL Expert and plans to use the ITIL CSI framework to structure the initiative.

Exercise

Produce a presentation based on the ITIL® CSI framework that provides a high-level view of how the CRM will start to introduce cyber resilience. The presentation should address the concerns expressed by the CIO.
